- at the venue in full in cash unless agreed in advance otherwise. Set up of our equipment will only commence when payment is made in full. .
- 2. If the CLIENT cancels the booking or the event does not take place for any reason then any deposit will be forfeited. A cancellation fee of £50 will also be applied for where the event is cancelled 7. Beat This Entertainment will require adequate with less than 48 hour's notice..
- 3. Beat This Entertainment will conduct themselves in a manner befitting the engagement and will respond to the CLIENTS requests relating to dress code, volume levels, music played, equipment location or any other reasonable request.
- 4. Beat This Entertainment will require access to a properly earthed mains electricity supply, sufficient to allow safe usage of the required equipment for the performance. If the supply is inadequate, then the amount of equipment may be reduced. If Beat This Entertainment considers that the electricity supply or any other aspect of the event is unsafe then they reserve the right to refuse to start or continue the performance after consultation with the CLIENT. The provisions of clause 2 may also apply.
- 5. Beat This Entertainment will use their best endeavours to attend the function. Should they be prevented from attending for any reason, including accident or sudden illness, then the CLIENT will receive a full refund of all monies paid to the Beat This Entertainment for that function, however Beat This Entertainment will not incur any additional liability for non-appearance.

- 1. Payment of any balance will be made on arrival 6. Licences for the performance of recorded music are only required at public events. In most cases private parties, such as wedding receptions, birthdays etc which are invitation only and attract no entrance fee do not require a licence. It is the CLIENTS responsibility to obtain such licences if required...
 - setting up time prior to the performance (minimum 45mins) and a sufficient period afterwards to dismantle and remove their equipment from the venue. The amount of time required is dependent on the package selected and the minimum is annotated on the disco planner. Should set up be delayed due to Venue error or late arrival of the CLIENT, Beat This Entertainment cannot be held responsible if we are unable to start our performance on time.
 - 8. The CLIENT is responsible for providing adequate supervision of all quests, staff and customers at the venue and will be liable for any loss or damage to equipment caused by guests, staff or customers.
 - 9. The CLIENT warrants that they are entitled to use the venue for the purposes of the event and performance and that the event does not breach any law, bye-law or conditions imposed on the property.
 - 10. Any extension of playing time is purely at the discretion of Beat This Entertainment and may be subject to other constraints, however they will do their best to accommodate any such request. Fees for extended times are £50 per hour, payable at the time of the request for extension. .
